When: Sunday, September 29, 2019

Where: Bangor Waterfront, Bangor, ME

Directions: From North: Take I-95 South to Exit 182A to merge onto I-395 E/ME-15 S toward Bangor/Brewer/ US 1A /ME-9 for approximately 1 mile. Take Exit 3B for US 1A E/US-202 E/downtown Bangor. Merge onto US 1A E/US 202 E/Main Street and continue approximately 1 mile to Railroad Street. Turn right on Railroad Street over the working railroad tracks and around to the left to Waterfront Park.

From South, I-95 North take exit 182A to merge onto I-395 E/ME-15 S toward Bangor-Brewer/U.S. 1A/ME-9 for approximately 1 mile. Take exit 3B for U.S. 1A E/US-202 E/Downtown Bangor. Merge onto U.S. 1A E/U.S. 202 E/Main Street and continue approximately 1 mile to Railroad Street. Turn right on Railroad Street the working railroad tracks and around to the left to Waterfront Park.

- Rally-O: Novice A/B, Intermediate, Advanced A/B, Excellent A/B
- Junior Showmanship: Novice/Open (9-12 years), Intermediate (12-15), Open Senior (15-18)
- Adult Handling: 18 and older (judged on handling ability) – Professional Handlers ineligible, champion dogs are ineligible, pointed dogs allowed

ENTRY FEE: \$8 for first entry, \$5 for additional entry of same dog.
Junior show as additional entry is free.
